Company Investment Terms and Conditions

1.) The Minimum Investment in the Starter Plan is \$100 and the profit percentage is 4% daily for 5 days.

(ii.) The Minimum Investment in the Gold Plan is \$40,000 and the profit percentage is 6% daily for 30 Days.

(iii.) The Minimum Investment in the Corporate Plan is \$6,000 and the profit percentage is 4% daily for 45 Days.

(iv.) The Minimum Investment in the Zonal Representative is \$100,000.

2.) Any Investment funds which is less than the minimum will not be credited into an investor's account until it is completed.

3.) At Maturity, an Investor can withdraw their capital and their profit.

4.) Withdrawals can only be done only at maturity not before maturity. An investor cannot make any withdrawal less than \$100.

5.) 7.) Deposit or withdraw will become active when the administrator checks statistics in less than 24hrs.

8.) Any Investment funds which is less than the minimum will not be credited into an investor's account until it is completed.

9.) At Maturity, an Investor can reinvest their funds without withdrawal. This is called "Reinvestment". In the Starter Plan, Reinvestment is limited only to two times (2x).

10.) At Maturity, an Investor can withdraw their capital and their profit. After withdrawals from an account, the top up percentage is 30% of the total withdrawal.

11.) The Top Up percentage after (2x) reinvestment is 45% of total withdrawals at maturity. Any reinvestment done over the standard limit attracts a rectification top up percentage of 75%.
